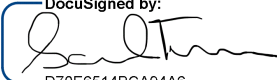
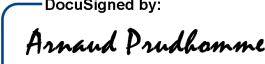

1. Purpose

At Taaleem Holdings P.J.S.C. (hereafter referred to as "Taaleem") we understand the value of education for families with multiple children. We are pleased to offer a Sibling Discount Policy to provide financial assistance to families enrolling their 3rd child and subsequent children at our schools. This policy aims to alleviate the financial burden on families with multiple children attending our institutions.

2. Scope

Families who have three or more children enrolled at any Taaleem premium school or Dubai Schools are eligible for a 10% Sibling Discount on tuition fees for the 3rd child onward, subject to the exceptions set out in Section 2c below.

a. Eligibility Criteria

- i. The Sibling Discount is applicable to families with three or more children simultaneously enrolled at any Taaleem school (Premium portfolio or Dubai Schools portfolio) within the Group portfolio of schools in the city of Dubai.
- ii. The discount applies to the tuition fees of the 3rd child and all subsequent children.
- iii. The discount is applicable on the KHDA approved tuition fee and does not extend to other fees.
- iv. To qualify for the discount, enrolled children must share a common legal guardian.
- v. The Sibling Discount is non-transferrable but can be combined with discounts such as scholarships, referrals, bursaries/hardship discounts, and staff discounts provided by the school. The Sibling Discount cannot be used in conjunction with other discounts such as Founders Fee discounts or any Corporate Partner discount under the active Corporate Discount Policy.

b. Exceptions

i. **Applicable to Lycée Libanais Francophone Privé Meydan "LLFPM" only**

Families of students enrolled in LLFPM receiving a sibling discount of 15% for the 3rd child and 25% for the 4th and each subsequent child, will be grandfathered and remain in effect until the student graduates. These families will also remain eligible to receive the same discount for any additional children subsequently enrolled at LLFPM.

From the 2025-26 academic year onwards, any new families enrolling at LLFPM will follow the standard sibling discount structure applicable to other Taaleem schools, i.e., 10% for the 3rd child and onwards.

ii. **Applicable to Dubai Schools only**

Families currently receiving a sibling discount will continue to benefit from it for

children already enrolled and eligible. Any new siblings enrolling from the 2026–27 academic year onwards will be charged the full applicable tuition fee (no sibling discount will apply).

3. Application Process

- a. Families seeking the Sibling discount must provide appropriate documentation such as birth certificates or other legal documents, to establish a common guardian relationship of the enrolled children.
- b. Families are required to inform the school's Admissions Office about their eligibility for the Sibling discount. This notification should be made either at the time of initial enrolment or during the re-enrolment period for existing students.
- c. The school Admissions Manager is responsible for verifying the eligibility of the siblings based on the provided documentation. Once that is confirmed, the school will proceed to apply the Sibling discount to the appropriate tuition fees for enrolled children.

4. Duration of the Discount

The Sibling discount will remain in effect for the entire duration of the academic year during which all eligible siblings are enrolled.

5. Changes to Enrolment Status

- a. The sibling discount at Taaleem schools covered under this Policy is applicable when parents have three or more children enrolled, offering a financial incentive for larger families. However, it should be noted that the discount would be revoked if there are fewer than three kids enrolled (due to a child leaving to go to another school, graduating etc).
- b. Any change will come into effect the beginning of the following term. For example, if a student withdraws, graduates, or enrolls mid-term, the adjustment to the fees would be made from the beginning of the next term.

6. Implementation Timeline

This policy shall be implemented within thirty (30) days from the Effective Date indicated on the cover page, allowing adequate time for communication, training, and adoption across all relevant Taaleem entities. Where any requirement in this policy is dependent on a system functionality, configuration, or tool that is not yet implemented, such requirement shall take effect only once the relevant functionality is operational. Until such time, existing processes shall continue to apply.

7. Non-Compliance

Deliberate and / or repeated non-compliance with this policy may be addressed in accordance with applicable company procedures.
